Further discussion programs will be designed to increase membership and to fulfill the mission of the commission.

Mary Lee Gilmore stated that we have 61 documented languages in Monmouth County and should get a good representation from these groups.

Suggestions: a letter of invitation be sent to a number of groups inviting each to come to an open house (possibly our October meeting?) to meet and discuss ways to communicate our mission, increase membership, and help develop programs of interest to our communities and that stay within our mission.
