- I. The Call to Order was followed by the Salute to the Flag at 3:35PM.
- II. Approval of August 2014 Meeting Minutes Carolyn moved and Darryl seconded, with the minutes approved unanimously.
- III. Treasurer's Report no report.
- **IV. Standing Committees and Support Teams**
 - a. Membership Linda reported that no new member applications as of yet, but is hoping that the open house will result in new applications.
 - b. Communications Please send information that will be sent to members of the public to Carolyn for approval.
 - c. Incident Response reporting Nothing to report as the committee has to meet to discuss ongoing issues.
 - d. Resource Development -no report.

V. Unfinished Business:

a. Planning for the Open House– Linda summarized earlier discussions to invite like-minded community groups in Monmouth County to a meeting to discuss issues of interest to them. There is now a draft invitation and a list of groups to invite is being compiled. Linda made four suggestions for the meeting: determine a date, time, place; compile a list of community invitees; develop an invitation; and setting the agenda for the program, to be determined by Darryl. Linda proposed the Executive Committee meeting date of March 2 at the regular time (3:30PM) or the April meeting (April 13) in the evening (7:00PM), preferably at the Neptune location. Linda will contact Sondra to see if the facility is available at that time.

She also thought a town meeting format would draw more discussion. As to the list of invitees, the aim is to include a variety of community groups throughout Monmouth Count y, such as different cultural groups, human relations-oriented groups, language and ethnic groups, as well as religious groups. Darryl and Rev. Pierce will edit the church groups prepared by Inderjit, and asks anyone to send groups they think should be included to Darryl by the November meeting (Please include the name and contact information for the group).

Darryl suggested creating an online survey to solicit information from groups that can't send representatives to the meeting, as well as using other sorts of social media. Carolyn is willing to send out a PSA message to media outlets and perhaps even pay for an ad. Linda will rework the letter of invitation and send to the members attending for their comments.

As to the approach or agenda for the meeting, a diversity gettogether and a discussion of what to do at the meeting took place. Possible questions might include—What are the major issues relating to human relations that your group faces? What should a county human relations committee deal with? The list, letter, and agenda will be finalized at the November meeting. Linda suggested forming a committee of five people to address the letters.

- b. November Human Rights Conference A discussion of sending members to the event took place. Linda, Carolyn seconded, Motion to send up to two people to the conference and it was approved. Sherri will send out a special appeal for members, letting her know by Oct. 15th, for attendance and reporting back at the December meeting.
