- I. The Call to Order took place at 3:38PM, followed by the salute to the flag and a moment of silence for the victims of the Los Vegas gun violence.
- II. 3:30-4:30PM Program--"Immigration Concerns in Monmouth County"

Rita Dentino, Casa Freehold and Dina Mansour, NJ Alliance for Immigrant Justice, presented on Immigration Concerns in Monmouth County. Key points: Monmouth Co. is one of four counties in NJ that has agreed to 287g for the County jail, DACA is scheduled to end on Oct. 5, and the future of the "dreamers" is uncertain. ICE is using some new methods to track undocumented immigrants including ankle bracelets and portable finger print machines. St. Thomas in Red Bank is establishing a sort of satellite of Casa Freehold. Communities may adopt "fair and welcoming" policies - as Red Bank has - which limit interaction with ICE.

Items which might be fruitful topics of discussion at a 2018 meeting would be: the possibility of revoking 287g, encouraging the county and municipalities to adopt fair and welcoming policies, consider assisting with distribution of the landlord cancellation letter which enables tenants to regain security money on vacating.
